Applications must be received by the selection committee no later than March 15, 2010

ALL ENTRANCE FEES DUE WITH APPLICATION	\$10.00 jury fee (non-refundable) SEPARATE CHECK, PLEASE \$50.00 for 10x10 space if you supply your own tent \$75.00 for 10x10 space inside a provided group tent
DISPLAYS	Artists are responsible for their means of display— partitions, chairs, tables etc. Eight foot tables can be reserved for \$10.00 each
SET-UP	Artists may set up on Saturday June 12 between 1:00 and 5:00 PM and Sunday morning prior to 10:00 AM. Volunteers will be available to assist those who need it. Security will be provided over night Saturday until Sunday morning.
SELECTION	Applications plus a minimum of four samples of your work in photo or CD format will be reviewed by committee. Notices of acceptance will be mailed within 2 to 4 weeks of application receipt. For applicants declined, funds minus the jury fee will be returned. However if you wish your photos/CDs returned, you may include a self-addressed and stamped envelope or you can make arrangements to pick them up at the Little Art Gallery. A maximum of 20 artists can be accommodated in group tents. Another 20 to 40 artists with their own tents will be accepted. Artists wishing to demonstrate are encouraged but it is not mandatory.
