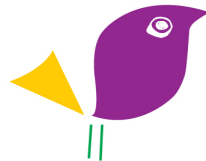

HeARTS with Hope Public Arts Contest 2011:
Open to artists of all ages and performance levels.
This art competition is devoted to promoting Hope,
Strength, and Promise. Proceeds from the event
benefit Domestic Violence Project, Inc. of Stark
County, Ohio.

Hearts With Hope

Eligibility...

The competition is open to all artists. There are three categories of participation including:
Student Artists - ages 18 and under
Amateur Artist - 18+ and not utilizing the sale of your art as a method of income
Professional Artist - age 18+, working professional in the art industry

Jury Fee...

There is a \$15 non-refundable jury fee required for each artistic entry. Make checks payable to Domestic Violence Project, Inc. (DVPI) We also accept VISA or Mastercard.

Deadline...

Submission deadline is January 28, 2011 at 5pm. There will be no extensions. Artwork should be submitted to ArtsinStark, and must be accompanied by the official entry form, and jury fee.

Prizes...

This year there are many opportunities for participants including the chance to *win a \$500 cash Best of Show prize*. (One cash prize will be awarded spanning all three categories.) In addition, the Best of Show artist will have a *virtual gallery for one year* on the DVPI website. All artists who participate in the contest have the opportunity to be selected for a *year-long traveling gallery*, promoting the *Hope, Strength, and Promise* associated with Domestic Violence Project, Inc. (The Best of Show cash recipient will not receive any additional compensation/commission from the auction of their piece.) The Best of Show winner will receive *two tickets* to attend the Hearts of Hope event, Friday, March 11, 2011 where the piece will be auctioned.

Exhibition / Commission...

All artwork entered will be on exhibit on February 3 & 4, 2011 at Patron Preview and Public Art Exhibitions. All works, except the Best of Show winning piece in each category, will be for sale at the exhibitions. If a piece sells during exhibition, a 25% commission will be retained by DVPI.

Medium & Theme...

Painting, drawing, photography, graphics, digital art, ceramic art, and sculpture are eligible. Theme should reflect a positive outlook; incorporating hope, strength & promise.

Presentation Guidelines...

Works must not be taller than 96" nor wider than 60"; Works can be framed by artist / presentation at the discretion of the artist.

Judging Notification & Return of Materials...

The winner will be selected by a qualified panel of judges the week of January 28, 2011. Artists will be encouraged to attend the Patron Preview & Awards Announcement on Thursday, Feb. 3, 2011. Works of art that are not sold and/or chosen for the traveling exhibition can be picked up at ArtsinStark February 9-11 2011. No items will be shipped. If items are sold during exhibition, a check will be mailed within ten days.
